MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING ("MOU") is entered into by and between the SAN LUIS OBISPO COUNTY COMMUNITY COLLEGE DISTRICT ("District"), the CUESTA COLLEGE FEDERATION OF TEACHERS (CCFT), AFT Local 4909.

TERMS

The parties have entered into this MOU for the purpose of setting forth their good faith understandings and commitments regarding the use of increases in Course Caps to mitigate course reductions. The terms of the agreement are as follows:

- College savings generated by increases in course caps will be applied to reduce the negative impacts on the academic programs, courses, or sections that have been modified as a result of the district's Long Term Budget Reduction Plan (2013-2017) as approved by the Board of Trustees on December 12, 2012 (see attached summary from Dec 12, 2012 Board Packet).
- 2. Calculation of the dollar value of the concessions will be determined by mutual agreement between CCFT and management.
- 3. The application of the dollar value of the increases in course caps will be applied to maintain the viability of certificate and degree programs of the modified programs identified in the district's Long Term Budget Reduction Plan (2013-2017). The district will consult with CCFT and the Academic Senate on how to apply accrued savings from course caps increases before Fall 2013 schedules are due. In instances where faculty are not contractually available, a written plan will be given to the CCFT Executive Board and the President, Vice President, and Curriculum Chair of the Academic Senate. In such instances, the CCFT and Academic Senate leadership have ten (10) business days to respond. The final decision as to which courses are to be restored with the accrued savings will be determined by the Vice President of Academic Affairs and will be conveyed in writing to the CCFT and Senate Presidents, respectively.
- 4. The Course Caps increases to be compiled and applied to the modification of programs per the Long Term Reduction Plan (2013-2017) include only those provided by the Curriculum Committee by December 7, 2012 and submitted to the District on December 12, 2012 (see Attached Summary from the Curriculum Committee). These Course Caps increases will be implemented in Spring 2013.

By their signatures below, the signatories certify that they are the authorized representatives of either the district or the Federation and that any and all actions necessary for the parties to ratify and accept this MOU as a binding agreement have been completed in the manner required by that party. Upon affixing the signatures below, this MOU is entered into without the need for further ratification and acceptance.
